#### **Entry Requirements**

You need to be between 16 and 18 on 31 August of the year you start the course.<br/>
Fyou should have 5 GCSEs at grade 5 or above, including Maths and English. We can accept alternative equivalent qualifications, too.<br/>
Fyor I/> Additionally, this course requires one reference (usually from your school) and it is desirable that you can demonstrate a minimum of 90% attendance at your last place of study.

# How you will be assessed

You will be assessed via a variety of formal methods during your course plus assessments such as external exams, controlled assessments, an employer-led set project, and summarising your learning through practical assignments. <br/>
- br /> - This will generate an overall grade of pass, merit, distinction, or distinction\*. You will be awarded a nationally recognised certificate which will show a breakdown of what you have achieved and can be worth up to 168 UCAS points.

## **Course Fees**

There are no tuition fees to study a T level if you start before you are 19 years old but there will be material costs that will need to be paid at the start of the course.<br/>
For I/> course is for under 19s only.

### **Course Progession**

Achieving this technical qualification will provide several progression options. These include: <br/>
- skilled employment - legal services roles such as business assistant in a legal services function, or an EO caseworker.
- apprenticeship in paralegal or Level 4 Conveyancing Technician
- higher level study: Higher Technical Qualification (HTQ)
- degree related programmes such as Law, Criminology or Business Studies
